Policies

Focus and Scope

The Journal of Equity in Education is a peer-reviewed scholarly publication of New York University's Metropolitan Center for Education and the Steinhardt School of Culture, Education, and Human Development. It is designed to provide an accessible forum for original and emerging scholarship that explores the topic of equity, as it pertains to race, gender and national origin, in education.

Section Policies

Invited Submissions -- peer reviewed

To lead each issue, the Editorial Board invites scholars and academics of note to share their thoughts on critical themes and issues around equity.

Peer Reviewed Articles -- peer reviewed

These articles are submitted to the Journal in response to a call for papers and are evaluated and chosen through a blind peer review process.

Peer Review Process

The Journal is committed to a blind peer review process. As such, it relies on dedicated group of reviewers to evaluate and provide comments on its submitted manuscripts.

The peer reviewer pool is comprised of doctoral students, professors, and other experts in the field of education with particular interests in equity issues pertaining to race, gender, and national origin.

Authors will first submit manuscript proposals. The Journal editors will then review each proposal with respect to the manuscript's suitability to the Journal's mission and call for paper. If the manuscript proposal is accepted by the Editorial Board, the author(s) will be asked to submit a full manuscript for peer review.

Full manuscripts will also be assigned to a panel of three peer reviewers with specific knowledge around the submission's themes or topics. The peer reviewers will provide evaluative feedback to the manuscript author(s) and recommend to the Editorial Board whether the manuscript should be accepted for publication.

Publication Frequency

The Journal is published biannually with a fall/winter issue and a spring/summer issue.

Open Access Policy

The Journal provides immediate open access to its content on the principle that making research freely available to the public supports a greater global exchange of knowledge. As such, each article is available free for download for private, noncommercial purposes.

Mission Statement

The mission of the Journal of Equity in Education is to provide a forum for original scholarship that explores the topic of equity, as it pertains to race, gender and national origin, in education. This journal is

premised on the notion that each child is entitled to a high-quality education. At its most basic level, this high-quality education includes, but is not limited to, a safe and healthy learning environment, a rigorous curriculum, and compassionate and capable professionals in schools. Despite decades of struggle for the educational rights of children, inequities persist in our nation's educational system. These inequities manifest in poverty, race and gender discrimination, and xenophobia and create a myriad of obstacles that prevent some children from obtaining the educational opportunities afforded to the more privileged. The Journal of Equity in Education welcomes submissions that elucidate, open discussions around, and generate solutions to the pervasive and oftentimes hidden issues pertaining to educational equity. We are especially interested in emerging voices that confront these issues with fresh, new, and insightful ideas that can advance existing research and support possible solutions to related educational challenges.

Author Guidelines

Submission Guidelines

The Journal of Equity in Education is especially interested in emerging voices that confront the issues of educational equity with fresh, new, and insightful ideas that can advance existing research and support possible solutions to related educational challenges. Submissions will be assessed on topic suitability, originality, strength of scholarship, and cogency of argument.

The most recent "Call for Papers" on the Announcements page has more specific information about topics for the upcoming issue and deadline information.

Papers should be approximately 10-15 pages in length (not including references), conform to the APA style manual, and include page numbers in the heading. Manuscripts must be submitted electronically in a format compatible with Microsoft Office (.doc) through the Journal website. Please refer to the "Submission Preparation Checklist" for addition guidelines.

Submission Preparation Checklist

- As part of the submission process, authors are required to check off their submission's compliance with all of the following items, and submissions may be returned to authors that do not adhere to these guidelines.
- 1. The submission has not been previously published, nor is it before another journal for consideration (or an explanation has been provided in Comments to the Editor).
- 2. The submission file is in Microsoft Word (.doc) or RTF document file format.
- 3. Where available, URLs for the references have been provided.
- 4. The text is single-spaced; uses a 12-point font; employs italics, rather than underlining (except with URL addresses); and all illustrations, figures, and tables are placed within the text at the appropriate points, rather than at the end.
- 5. The text adheres to the stylistic and bibliographic requirements outlined in the most recent edition of the <u>Publication Manual of the American Psychological Association</u>.
- 6. If the submission contains a graph or chart copied from a previously published source, permission has been obtained to use this graph and chart.
- 7. If submitting to a peer reviewed section of the jounral, the submission is free of anything that might identify the author(s).

Copyright Notice

The Journal of Equity in Education is a copyrighted publication of New York University

Authors publishing in the Journal will be asked to sign an author agreement outlined below:

- 1. Authors grant to the *Journal of Equity in Education* exclusive first publication rights of their Articles and other such rights as are enumerated below. Authors will retain the copyright to their Articles.
- 2. Authors grant the *Journal of Equity in Education* exclusively for a period beginning when this agreement is signed and ending one year after the publication date of the Articles, and nonexclusively thereafter, the rights to print, reproduce, distribute, and sell the Articles, or any portion thereof, in all manners customary to publication of a scholarly journal including, but not limited to: publication as part of an Issue, publication as individual reprints, reproduction as part of a bound volumes including the Issue, and reproduce in a collection published by the *Journal of Equity in Education*.
- 3. Authors grant the Journal of Equity in Education exclusively for a period beginning when this agreement is signed and ending one year after the publication date of Articles, and nonexclusively thereafter, the rights to authorize others to publish portions of or the entire Articles, including translations into any language, in journals, magazines, newspapers, casebooks, treatises, and anthologies. After the first year, authors may also grant third parties to use and publish their articles, provided that you require such user or publisher to cite to the initial publication in New York University's *Journal of Equity in Education*.
- 4. Authors grant the *Journal of Equity in Education* the exclusive right to license their Articles for inclusion in electronic database services, including but limited to ERIC, ProQuest, and JSTOR.
- 5. Authors reserve the right to distribute draft copies of their Articles prior to publication in any manner customary to academic communications, including electronic distribution on the Social Science Research Network (SSRN), provided that the reproduction includes notice that it is a draft and that publication will be forthcoming in the *Journal of Equity in Education*, and further provided that the posted draft is replaced with the a link to the published version and/or an abstract upon publication.
- 6. Authors grant teachers, instructors, lectures, and professors at educational institutions the right to print and photocopy portions of or the entire Articles for educational use, provided that: (a) the copies are distributed or made available to students at or below cost; (b) the initial publication of the Articles in the *Journal of Equity in Education* is cited on each copy; and (c) proper notice of copyright ownership is affixed to each copy.
- 7. Authors represent and warrant that their Articles constitute their own original work, that no part of their Articles has been published before, and their Articles do not plagiarize or infringe the copyright, trademark, patent, or other rights of any person or entity, nor does it defame, invade the privacy or, or otherwise violate the rights of any person or entity. Authors further represent and warrant that they have obtained the appropriate permission to use any copyrighted graphs, photos, charts, images, or any other copyrighted material used in their Articles that were originally published in a third-party source. Authors further represent and warrant that their Articles have been withdrawn from consideration for first publication in any other journal, edited volumes, or conference proceedings.
- 8. Authors indemnify and hold harmless New York University, the Steinhardt School of Culture, Education, and Human Development, the Metropolitan Center for Urban Education, and their respective employees, trustees, and agents from any loss, expense (including reasonable

attorney's fees), claim, or damages arising from a breach of any of the representations, warranties, or agreements made by you in this agreement.

- 9. Authors agree to comply with draft deadlines and to cooperate fully with the *Journal of Equity in Education* Editorial Board throughout the publication process. This includes, but is not limited to, cooperating with the Editorial Board when it seeks to make changes necessary to bring their Articles into compliance with the spelling, stylistic, and structural conversations of American scholarly journals and the *Journal of Equity in Education's* own established standards. The *Journal of Equity in Education* reserves the right, should the authors change more that 10% of their pieces from their acceptable version without consulting the *Journal of Equity in Education*, to revert to the originally accepting versions, amend the publication dates, or revoke publication. The *Journal of Equity in Education* further agrees to publish the authors' Articles subject to the understanding that they will not be published by the *Journal of Equity in Education* unless, in its final form, they are reasonably acceptable both to the author and to the Editorial Board of the *Journal of Equity in Education*.
- 10. This agreement shall be governed by the laws of the State of New York and the federal laws of the United States of America. The parties agree to submit any dispute arising hereunder to the federal of state courts located in New York County in the State of New York.
