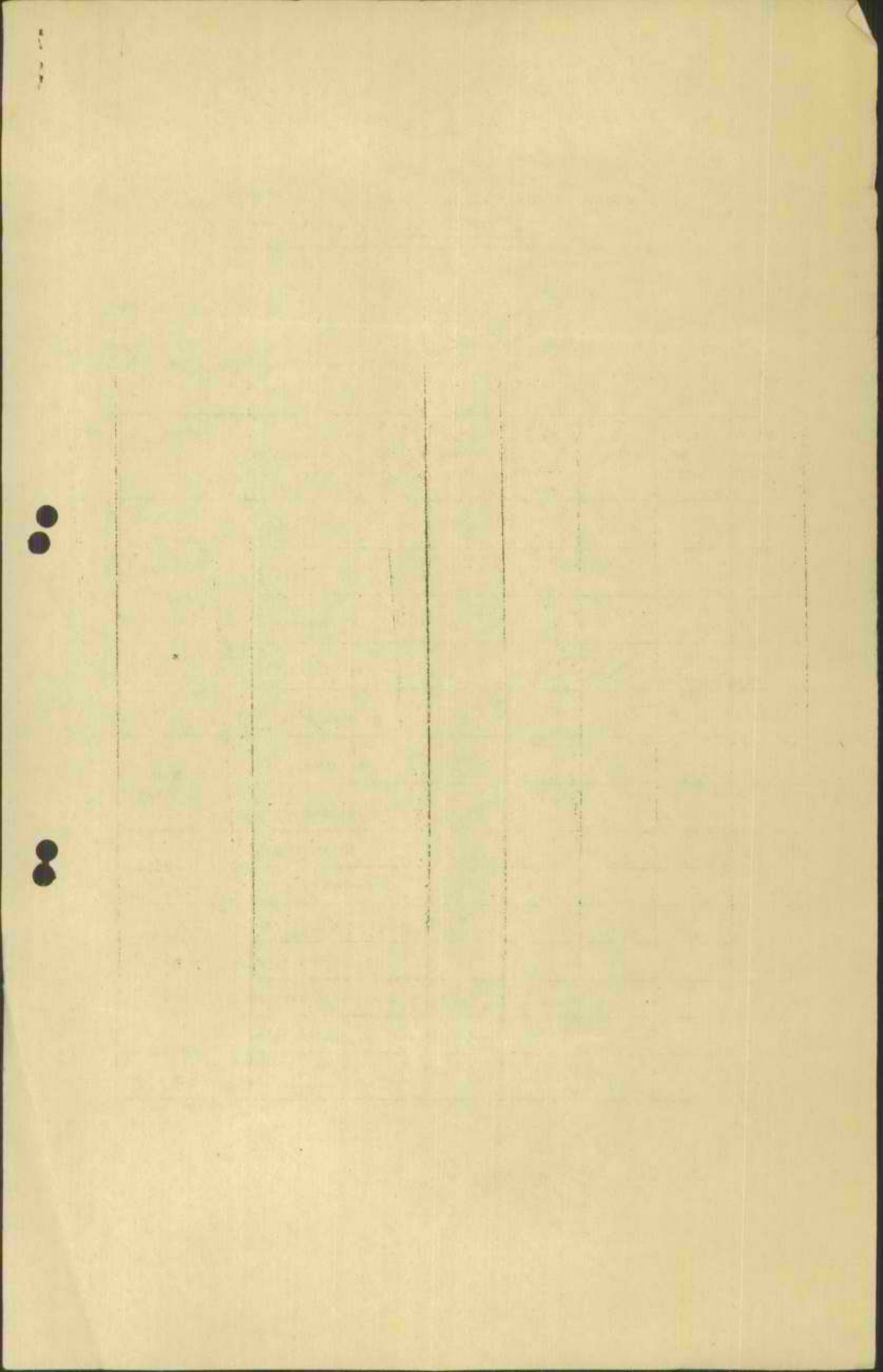

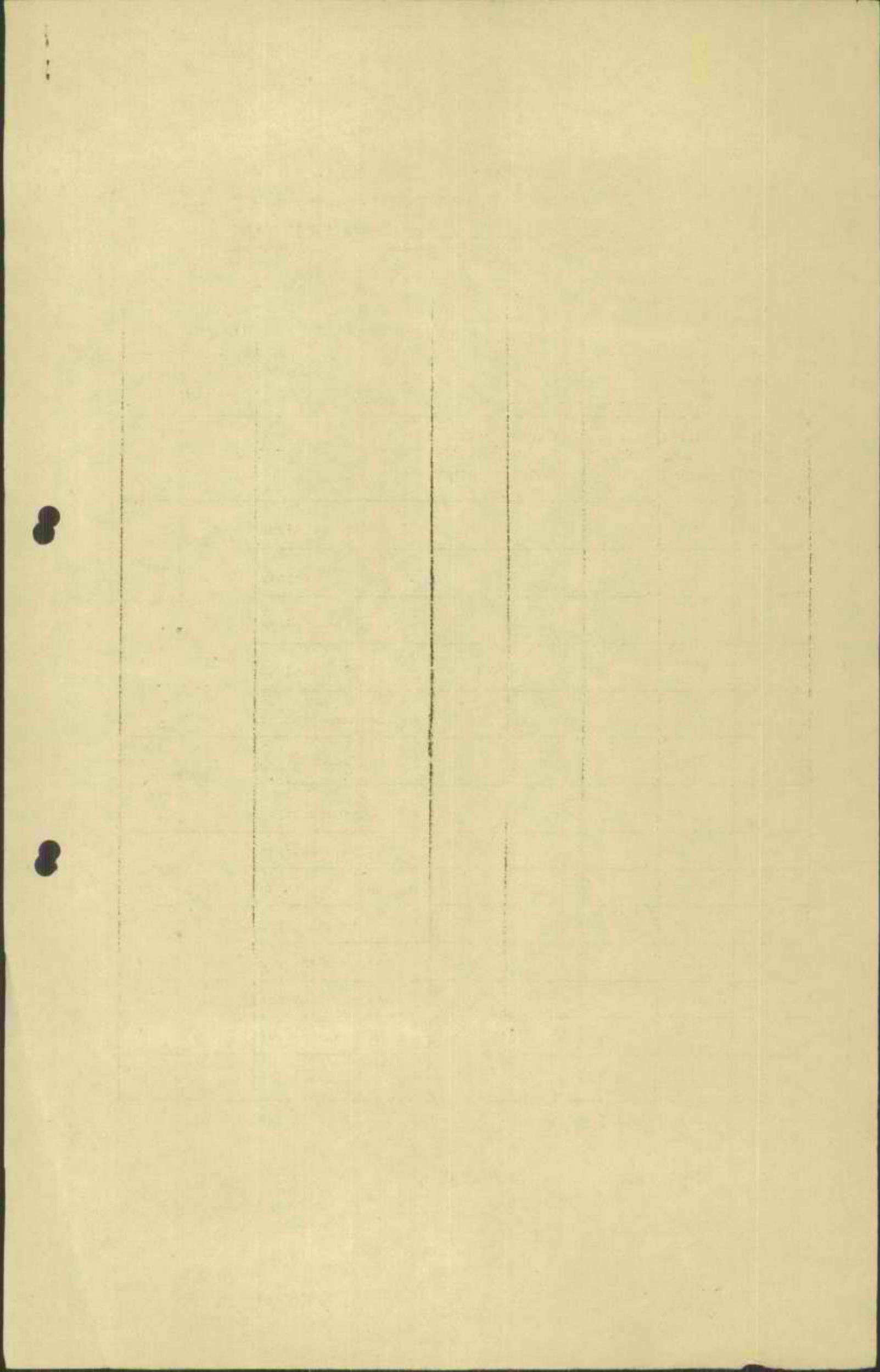

1. The High Court of Appeal (Civil)

- a. The Court received 2 Civil Cases.
- b. with 3 civil cases carried forward from November 1968.
- c. The Court held, during December, 2 sessions during which the Court heard all the cases brought before it. This Court decided one case and two were deferred in addition to two cases received precedent to fixing the time of the Court sittings.

2. The High Court of Justice

- a. The Court had one case pending from last month which was heard and deferred to the next sitting. No new cases have been received during this month.
- b. 1 case was carried forward from last month.
- c. During this month the court held one sitting during which a number of (-) decided and 1 deferred.

3. Miscellaneous Applications

The Court had no pending applications. It has received one application and was decided.

4. The Criminal Court of Appeal

- a. This Court received 7 Criminal appeals.
- b. with 11 cases carried forward from November 1968.
- c. The period from 11.12.68 to 15.12.68 was appointed for hearing the appeals. During this period the Court has decided 11 cases while 2 were deferred to a later session, in addition to 5 cases received after the appointment of the above sessions.

2. The incoming mail and the outgoing mail amounted to 57 and 60 successively. 5 of the outgoing mail was despatched outside Gaza. 400 summon for witnesses have been drawn up to notify the parties concerned of the hearing of their cases this month.

3. 5 Applications for release on bail have been submitted, 3 of which were decided and 2 are pending for action.

4. The Court received six cases of Execution. The parties concerned called on the Execution Office for payment of instalments due in about 40 cases. Persons not discharging their debts are notified thereof. Fixing dates for holding meetings of the Execution Board has carried out.

1. Criminal cases brought forward from November are two and were decided.
2. Misdemeanours cases brought forward from November are two in addition to one misdemeanour case in this months. All cases have been decided.
3. Correspondance received and sent out amounted to 18.
4. 8 bails and personal declarations have been prepared in accordance with the Courts' decisions.
5. This Court requested 15 reports from the social Investigator showing the conduct, the social circumstances, and the living surroundings of each person accused against whom cases have been brought. After receipt of such reports the Court tried all offenders and the contents of the reports received from the Social Investigator were taken into consideration.
6. The Court has drawn up seven orders for imprisonment of offenders in execution of the Court's judgement.
7. The Court has often invited the Social worker (conduct controller) to attend the sitting of the Court when trying Juvenile offenders so as to give the Court a picture on the offender's conditions and surroundings. The Court, as well, take into account, the recommendations made regarding the behaviour of the juvenile offender who commits again the crime while being in the Reformatory School.

Reference is made to your letter dated 28.2.1968 concerning the submission of a monthly report of the work done by this Office and the Offices attached to it.

1. The Office of the Public Prosecution has received during the month of December 1968, from the Summary Prosecution Offices and the Police Stations, the cases detailed in the annexed table. The Prosecution has disposed of such cases either by committing the accused persons to trial before the competent Courts or by having the case filed or recorded in the book of administrative complaints and sent them back to their sources as the case may be. It has also revised the judgements passed in connection with Misdemeanours and Traffic Contraventions cases and verifying them or otherwise and appealing from these judgements whatever we see that they require appeal and checking the works done by the Execution Office.

2. This Office received a number of 241 letters in connection with the work of the Offices of Public Prosecution and the various departments/sections. Replies thereof were made with certain comments in such manner as to ensure perfect running of the work.

3. This Office sent out a number of 579 letters constituting replies and remarks for the mail received and in connection with the cases placed under consideration.

4. The cases detailed hereunder were examined and seen. Bills of indictment and appeals were preferred thereto and submitted to the competent Courts (Criminal Court, Supreme Court - District Court in its two capacities). These cases were conducted in the name of the Attorney General. Judgements of decided cases were revised and approved and appealing therefrom whatever judgements requiring appeal:-

 Charge with: Breaking into a dwelling house with intent to commit burglary contrary to articles 294 and 295 of the penal code 1936.

On 15/12/1968 the Court of Criminal Assize of Gaza sentenced the accused after having been found guilty to imprisonment for 2 years with labour with effect from the date of the sentence passed.

6. The Public Prosecution Office represented by the Attorney General before the Criminal and District Court in hearing 3 applications for release on bail of persons detained in prison.
7. Checking and revising the weekly lists of judgements passed by the Magistrate Courts and the Examining Magistrates. Cases subject to appeals were also requested for perusal before the expiry of the prescribed period for the appeal.
8. Perusing of the weekly and monthly lists containing names of persons detained or acquitted with special note on the date on which these persons detained or acquitted taking into consideration the time limit on which cases could be remitted for trial or disposed of in respect of persons detained for a prolonged periods without any justified reasons.
9. Examining the sentences passed by the Magistrate Courts in respect of traffic cases and Misdemeanours and making appeal to those cases requiring appeal.
10. Investigating complaints referred to the Office of Public Prosecution and disposing of them as they may require either by sending them to the Investigation Offices for opening files for them and put them down on the records of offences reported daily.
11. Reviewing applications for extension of periods of detention and its related cases and approving the orders of extension for a period of more than one month according to the charges brought against the accused and the degree of its grievance and giving orders to enhance disposal thereof.
12. Checking applications for acquittal referred to this Office from the various Sections/Departments giving decision whether approved or not and return them to their sources for disposal.
13. Supervising the daily work of the Offices of Summary Prosecution and giving the necessary instructions which ensure smooth running of work.

(4) תיקון חוק התובלה בודרכים סמ" 49 לשנת 1968: סעיף 187 (נוסף) של חוק התובלה בודרכים סמ" 49 לשנת 1968 כפי שהוקן ע"י החוק סמ" 80 לשנת 1966 קובע בזירה קנס של דיגרי אחד ביחס לכל העבירות על חוק התובלה בודרכים. השופטים מציעים לבטל את הסעיף החוקן הנ"ל על מנת להחזיר את הסקול ביחס לעונש לטופטים. הצעה אלטרנטיבית הינה לצמצם את היקף הסעיף 187 (נוסף) הנ"ל לעבירות מסוימות ולהשאיר את הסקול כיותר העבירות - התגברות יומרי - לבית המשפט.

(5) התכנסות עורכי-דין של האיזור לפני השופטים: נשיא בית המשפט לערכאה ראשונה - דרוס העיר כי לעתים מחיימים עורכי דין באיזור בזלזול או בהוצאה כלפי השופטים במנייתם הם פוזיעים. ע"מ חוק עורכי דין הודרתיים סמ" 11 לשנת 1966, ניהנה הטמכות ביחס לעבירות על התחיקה המקצועית בידי בית דין שסמקתי טליד לשכת עורכי-הדין. מאחר והקום מוטבה של הלשכה כרבה עמוך, לא ניהון להעמיד עורכי-דין לדין סממתי בגין התגברות בבית המשפט או אומן מילוי המקרים.

הועלו מספר הצעות וביניהם להאשר לפני המשפט הרגילים לשופט עורכי-דין על התגברות או לחקיס באיזור לשכה נאורית, אולם הצעה הרווחת בין השופטים הייתה להשאיר לעת עתה את המצב כפי שהוא, ולכוונן אמטיות להפריד בין עורכי הדין של האיזור לבין הלשכה טכמטן - אשר, הגב, וחלה לחקיק לעורכי הדין ולשופטים באיזור ע"י ששפטים סממתיים נגויה התגברות העמטן - כסיגורל מסמר עורכי הדין והמוכנים לעבוד באיזור.

(6) העזרה השפטיה בין האיזור לבין ישראל: כהטובה לשאלה הנשיא והשופטים בגיריון הודרתי כי העניין עודנו במטול.

הודרתי לשופטים באותו מעמד על הצינויים הודרתיים הקומדיים להתפרט. שופט השלום ביריחו אשר עמד להתגברות ברמאללה ביקש להשאירו במקומו, ספיבות סממתיים, וזאת על אף הסמטתו הקודמת להכרעה. עקב בקשה זאת אני עומד להציע לועדת מינוי שופטים של האיזור להשאיר את שופט השלום של יריחו במקומו ולהעביר את החובע אבו-טווי אשר עמד לעבור ליריחו, לבית לחם במור טופט שלום. שופט השלום של בית לחם, האנטיק אל סקה, ימתן טמטט פרטתה ראשונה ברמאללה.



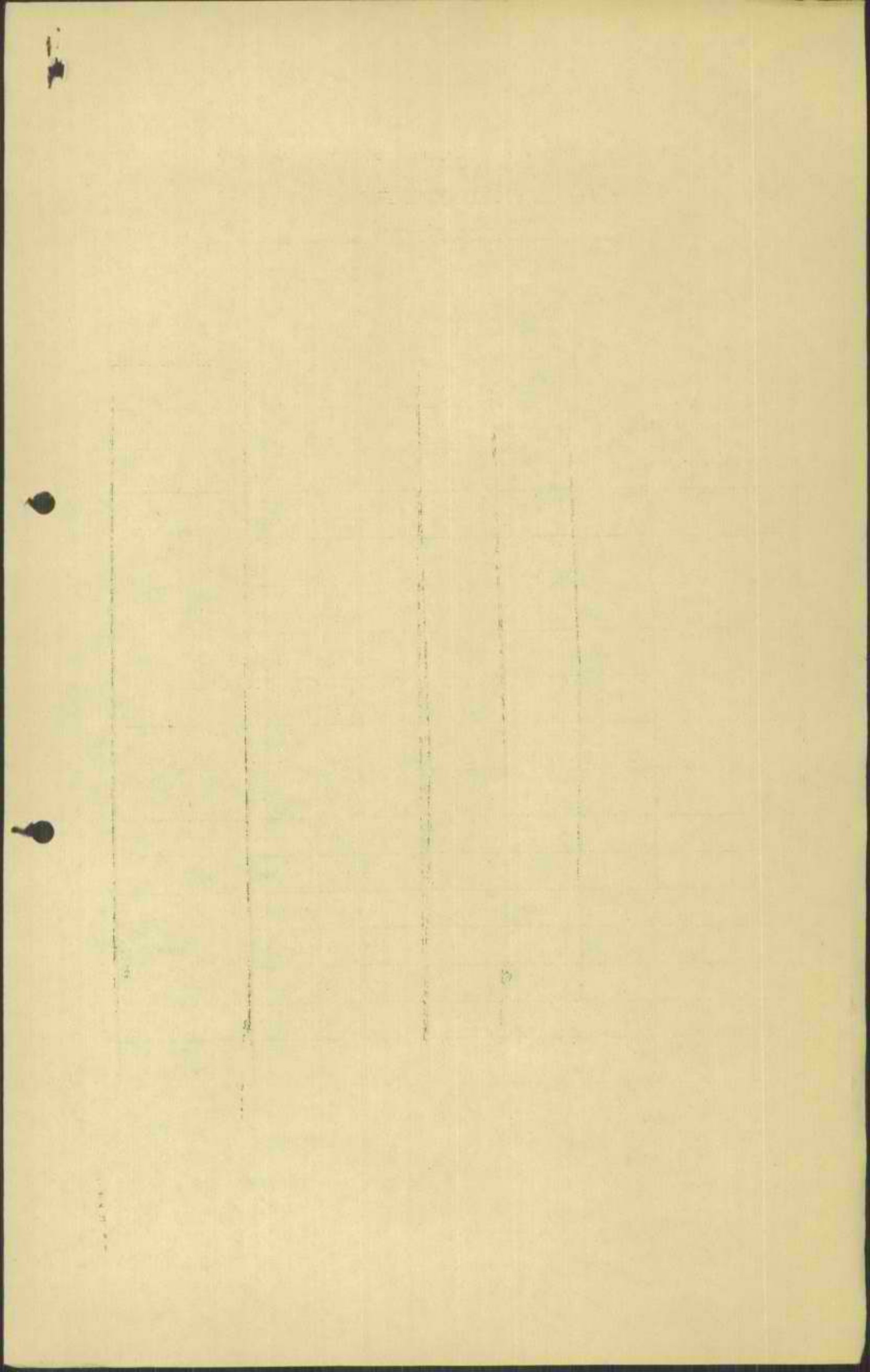

Reference is made to your letter dated 28.2.1968 concerning the submission of a monthly report of the work done by this Office and the Offices attached to it.

The following is the report of November 1968:-

1. The Office of the Public Prosecution has received during the month of November 1968, from the Summary Prosecution Offices and the Police Stations, the cases detailed in the annexed table. The Prosecution has disposed of such cases either by committing the accused persons to trial before the competent Courts or by having the case filed or recorded in the book of administrative complaints and sent them back to their sources as the case may be. It has also revised the judgements passed in connection with misdemeanours and Traffic contraventions cases and verifying them or otherwise and appealing from these judgements whatever we see that they require appeal and checking the works done by the Execution Office.

2. This Office received a number of 281 letters in connection with the work of the Offices of Public Prosecution and the various departments/Sections. Replies thereof were made with certain comments in such manner as to ensure perfect running of the work.

3. This Office sent out a number of 621 letter constituting replies and remarks for the mail received and in connection with the cases placed under consideration.

4. The cases detailed hereunder were examined and seen. Bills of indictment and appeals were preferred thereto and submitted to the competent Courts (Criminal Court, Supreme Court - District Court in its two capacities). These cases were conducted in the name of the Attorney General. Judgements of decided cases were revised and approved and appealing therefrom whatever judgements requiring appeal.

DECLARATION OF INDEPENDENCE

When in the course of human events, it becomes necessary for one people to dissolve the political bands which have connected them with another, and to assume among the powers of the earth, the separate and equal station to which the laws of nature and of nature's God entitle them, a decent respect to the opinions of mankind requires that they should declare the causes which impel them to the separation.

We hold these truths to be self-evident, that all men are created equal, that they are endowed by their Creator with certain unalienable Rights, that among these are Life, Liberty and the pursuit of Happiness. — That to secure these rights, Governments are instituted among Men, deriving their just powers from the consent of the governed, — That whenever any Form of Government becomes destructive of these ends, it is the Right of the People to alter or to abolish it, and to institute new Government, laying its foundation on such principles and organizing its powers in such form, as to them shall seem most likely to effect their Safety and Happiness.

Prudence, indeed, will dictate that Governments long established should not be changed for light and transient causes; and accordingly, we have recourse to the remedy of a change only when the same have become destructive of the ends for which they were instituted. Now, in the second place, we must declare the causes which impel us to the separation. We have to complain of a long train of abuses and usurpations, which, whenever they had been united, would have amounted to a tyranny, and which, by their frequent repetition, have become a persecution. We have to complain of a monarch, who has endeavored to extend his tyranny to all parts of the continent, and to bring all the States under the same oppressive government.

He has refused to assent to our laws, unless they be first stamped with his seal, and has declared, that a refusal to do so, would be a crime. He has dissolved the Representative Branches of our Legislature, and has pretended to exercise the powers of that body, without the sanction of the People. He has affected to exercise executive powers, which are vested in the Senate and House of Representatives.

He has refused to assent to our laws, unless they be first stamped with his seal, and has declared, that a refusal to do so, would be a crime. He has dissolved the Representative Branches of our Legislature, and has pretended to exercise the powers of that body, without the sanction of the People. He has affected to exercise executive powers, which are vested in the Senate and House of Representatives.

He has refused to assent to our laws, unless they be first stamped with his seal, and has declared, that a refusal to do so, would be a crime. He has dissolved the Representative Branches of our Legislature, and has pretended to exercise the powers of that body, without the sanction of the People. He has affected to exercise executive powers, which are vested in the Senate and House of Representatives.

He has refused to assent to our laws, unless they be first stamped with his seal, and has declared, that a refusal to do so, would be a crime. On 17.11.1968, The Court of Criminal Assize of Gaza sentenced the accused while being present, to imprisonment for life with hard labour and ordered the return of the siezed objects i.e. the watch, the shoes and the money, to victim's wife.

6. The Public Prosecution Office represented by the Attorney General before the Criminal and District Court in hearing 6 applications for release on bail of persons detained in prison.

7. The hearing of 1 application for leave to appeal was conducted in the name of the Attorney General.

8. Checking and revising the weekly lists of judgements passed by the Magistrate Courts and the Examining Magistrates. Cases subject to appeals were also requested for perusal before the expiry of the prescribed period for the appeal.

9. Perusing of the weekly and monthly lists containing names of persons detained or acquitted with special note on the date on which these persons detained or acquitted taking into consideration the time limit on which cases could be remitted for trial or disposed of in respect of persons detained for a prolonged periods without any justified reasons.

10. Examining the sentences passed by the Magistrate Courts in respect of traffic cases and misdemeanours making appeal to those case requiring appeal.

11. Investigating complaints referred to the Office of Public Prosecution and disposing of them as they may require either by sending them to the investigation offices for opening files for them and put them down in the records of offences reported daily.

12. Reviewing applications for extensions of periods of detention and its related cases and approving the orders of extension for a period of more than one month in accordance with the charges brought against the accused and the degree of its gravness and giving orders to enhance disposal thereof.

13. Checking applications for acquittal referred to this Office from the various Sections/Departments giving decision whether approved or not and return it to its sources for disposal.

14. Supervising the daily work of the Offices of Summary Prosecution and giving the necessary instructions which ensure smooth running of work.

15. A board of traffic were sent to Summary Prosecution Offices of D/Balah K/Youness and Rafah to give an explanation in respect of the order issued by you regarding the organization of the work at the Prosecution Office of the Traffic Section.

- i. 4 Cases were sent back to the Investigation Offices of Gaza and Jabalia for completion of information necessary or amendment of the charge or because the offender has been known.
- j. 15 Cases were sent to the Public Prosecution Office together with a memo to be forwarded to the Acting Attorney General.

3. A big number of cases were copied out which belonged to the Magistrate Court and cases subject to remittal to the District Court and to the Criminal Court from the original copies of the Police Stations which are subject to appeal. All copies cases were forwarded to the Office of Public Prosecution.

4. Reviewing and prosecuting in Municipal cases brought before the Municipal Prosecution.

5. Carrying out the instructions passed by the Attorney General in respect of preparing lists of weekly judgements and consolidating the daily attendance sheets.

6. Making answers to and complying with the administrative instructions and orders received.

LECTURE 10: ELECTROSTATICS

The electric field E is defined as the force F per unit charge q . For a point charge Q , the electric field at a distance r is given by $E = kQ/r^2$.

The electric potential V is defined as the work done per unit charge in moving a charge from infinity to a point. For a point charge Q , the potential at a distance r is $V = kQ/r$.

The electric field is related to the potential by $E = -\nabla V$.

The electric field is a vector field, and the potential is a scalar field.

The electric field is perpendicular to the equipotential surfaces.

The electric field is parallel to the lines of force.

The electric field is zero inside a uniformly charged sphere.

א. בתי המשפט

1. בגלל עומס העבודה הרב בבית משפט השלום בעזה ומיעוט השופטים המכהנים בו, העברנו לבית משפט זה החל מה-15 בנובמבר את שופט השלום מר מוחמד מנסספא מהנא שניהן מקודם כשופט שלום ברפיח. במקומו הועבר לרפיח שופט השלום מר עידו יעקב לפני כן תקופת אימון קצרה בבית משפט השלום בחן יונס.
כיום מכהנים בבית משפט השלום בעזה ארבעה שופטים ובחן יונס נשאר שופט אחד בלבד.
2. במשך חודש אוקטובר נדונו בכל בתי המשפט באיזור 316 תיקים וכן 1723 תיקי תנועה ו-824 תיקים של בית המשפט העירוני בעזה.

ב. התביעה הכללית

1. בחודש החולף טיפלו בתי המשפט והפרקליטות כמספא גדול של תיקים המעורבים בהם השודים בביצוע עברות חמורות. המטרה הצליחה לעלות על עקבותיהם של קבוצת עבריינים אשר ביצעו בחודשים האחרונים מעשי שוד ורצח במקומות שונים באיזור.
חלקם של התיקים כבר נדונו ע"י בית המשפט וחלקם נמצאים בשלב של דיון בבתי המשפט או בשלב של הקירה והכנה ע"י הפרקליטות.

Reference is made to your letter dated 28.2.1968 concerning the submission of a monthly report of the work done by this Office and the Offices attached to it.

The following is the report of October 1968:

1. The Office of the Public Prosecution has received during the month of October 1968, from the Summary Prosecution Offices and the Police Stations the cases detailed in the annexed table. The Prosecution has disposed of such cases either by committing the accused persons to trial before the competent Courts or by having the case filed or recorded in the book of administrative complaints and sent them back to their sources as the case may be. It has also revised the judgements passed in connection with misdemeanours and Traffic contraventions cases and verifying them or otherwise and appealing from these judgements whatever we see that they require appeal and checking the works done by the Execution Office.
2. This Office received a number of 270 letters in connection with the work of the Offices of Public Prosecution and the various departments/sections. Replies thereof were made with certain comments in such manner as to ensure perfect running of the work.
3. This Office sent out a number of 543 letter constituting replies and remarks for the mail received and in connection with the cases placed under consideration.
4. The Course of work at Deir El Balah and K/Younes' summary Prosecution Offices have been inspected by the Chief Clerk of the Public Prosecution Office who submitted a report of his observations. These observations were settled so as to secure smooth running of the work.
5. The cases detailed hereunder were examined and seen, bills of indictment and appeals were preferred thereto and submitted to the competent Courts (Criminal Court, Supreme Court - District Court in its two capacities). These cases were conducted in the name of the Attorney General. Judgements of decided cases were revised and approved and appealing therefrom whatever judgements requiring appeal.

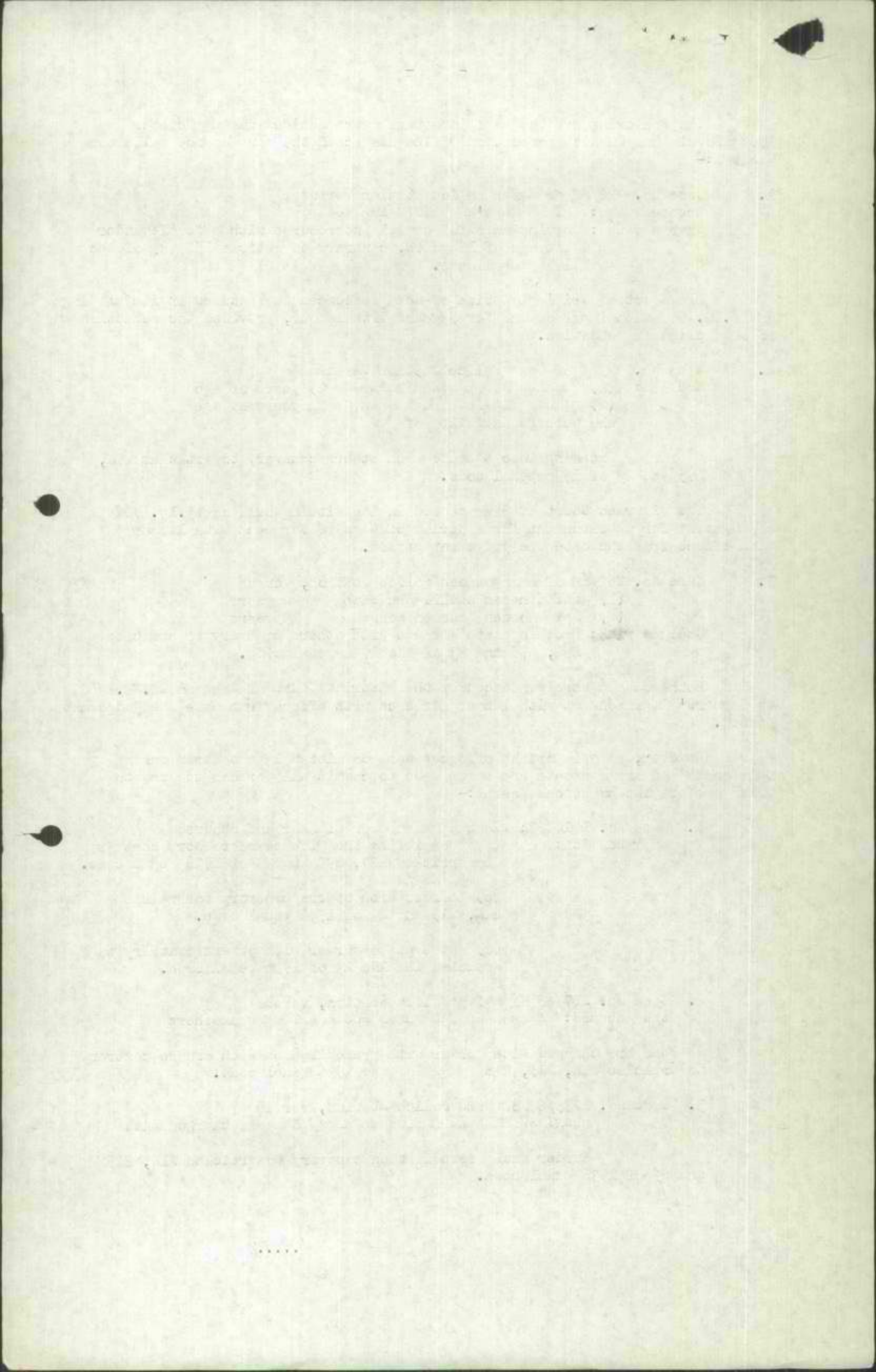

11. Investigating complaints referred to the Office of Public Prosecution and disposing of them as they may require either by sending them to the investigation offices for opening files for them and put them down in the records of offences reported daily.
12. Reviewing applications for extensions of periods of detention and its related cases and approving the orders of extension for a period of more than one month in accordance with the charges brought against the accused and the degree of its gravness and giving orders to enhance disposal thereof.
13. Checking applications for acquittal referred to this Office from the various Sections/Departments giving decision whether approved or not and return it to its sources for disposal.
14. Supervising the daily work of the Offices of Summary Prosecution and giving the necessary instructions which ensure smooth running of work.

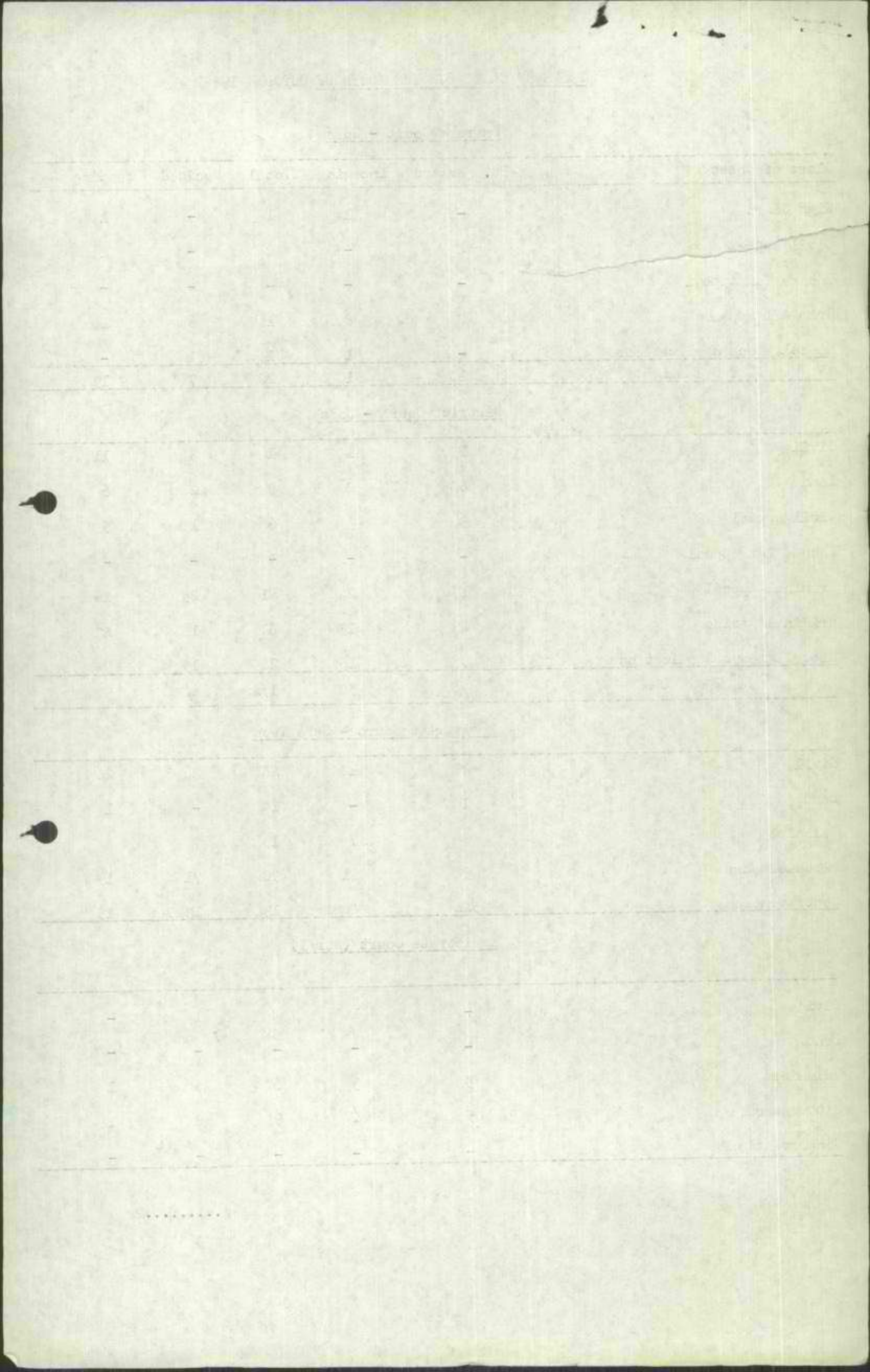



1. מבוא

א. החלת החוק הישראלי על מזרח ירושלים, יצרה מבחינת בתי המשפט, מספר בעיות אשר מצאו עד עתה פתרון חלקי בלבד:

(1) התיקים אשר נשארו תלויים ועומדים, ערב היום הקובע, בפני בתי משפט של ירושלים המזרחית: תקנות הסדרי משפט ומינהל תשכ"ט - 1968 מהווים פתרון לבעיה זאת. אולם חייבים אנו לקחת בחשבון שחלק מהאנשים המעורבים בהיקים הנ"ל, הינם עתה תושבי איזור יהודה והשומרון ועל כן, נשארת שאלת המסירה המשפטית ואכיפת פסקי הדין מעבר לקו הירוק בעינה.

(2) אכיפת פסקי דין של בתי המשפט של ירושלים המזרחית: תקנות הסדרי משפט ומינהל תשכ"ט - 1968, מהוות פתרון רק ביחס לפסקי הדין הנחנים להוצאה לפועל בירושלים.

ב. תביעות שבחס מעורבים תושבי ישראל ותושבי האיזור:

קיום תביעות משפטיות בין תושבי ישראל (כולל ירושלים המזרחית) לבין תושבי האיזור מעורר מספר בעיות:

(1) המסירה המשפטית.

(2) אכיפת פסקי הדין.

(3) ידיעת הדין המקומי והשפה העברית ביחס לישראלים הרוצים להתדיין באיזור.

(4) ידיעת השפה העברית ביחס לתושבי האיזור הרוצים להתדיין בישראל.

(5) המחסור בעורכי דין באיזור המורגש עוד יותר כתוצאה משביתת עורכי הדין.

2. א. מסירה הדדית של מסמכים משפטיים בין ישראל לבין האיזור:

תקנות אשר יותקנו בישראל וצו אשר יוצא באיזור לשם ביצוע מסירת מסמכים כנ"ל חייבות לכלול:

(1) סוגי המסמכים הניתנים למסירה.

(2) דרכי המסירה.

(3) הרשות המוסמכת לבצע את העברת המסמכים מבתי משפט ישראליים לבתי משפט באיזור ולהיפך.

בנוהל שיקבע לבצוע המסירות הנ"ל, חייבים לקבוע זמן מינימלי על מנת לאפשר העברת המסמכים מבית משפט המוציא את המסמך, לרשות המוסמכת, לבית משפט המבצע את המסירה והזרה.

ב. אכיפת פסקי דין, הדרך שנקבעה בתקנות הסדרי משפט ומינהל תשכ"ט - 1968, הינה אומנם הדרך המקובלת לאכיפת פסקי דין נוכריים. אף אם יתרבו התביעות ההדדיות בין תושבי ישראל לבין תושבי האיזור ונרצה לאכוף פסקי דין מעבר לקו הירוק בדרך דומה, הדבר יוסיף המדיניות רבות וארוכות. טאיך קשה לחשוב על בצוע אוטומטי של פסקי הדין מעבר לקו הירוק, בגלל ההדדיות הכרוכה בדבר. כשם שכל ישראלי מעונין שפסק דין יבוצע באופן אוטומטי באיזור, לא כן הרבר ביחס לפסקי דין של האיזור, אשר רוצים לבצע בישראל.

לכן הרעיון לקבוע בית משפט מיוחד בישראל, אשר מטמכותו יהיה לדון בבקשות לאכוף פסקי דין ישראליים באיזור ופסקי דין של האיזור בישראל.

3. בית משפט מיוחד:

- א. מטרה הראשונה של בית משפט מיוחד, תהיה לדון בבקשות לאכיפת פסקי דין ישראליים באיזור ושל האיזור בישראל.
- ב. רכוז הדיון בבקשות משני הכיוונים יזרו את הטיפול בבקשות הנ"ל ויהיה קרוב יותר לביצוע אוטומטי של פסקי הדין.
- ג. ניתן יהיה לקבוע אכיפת פסקי הדין, אפילו לא סופיים, על מנת שהזוכים בפסקי הדין לא יאלצו לחכות עד תום המועדים הקבועים, להגשת בקשה ביטול או ערעור.
- ד. בית משפט המיוחד ישמש מעין חוליה מקשרת בין בתי המשפט בישראל, לבין בתי המשפט באיזור.
- ה. קיום בית משפט כזה, ימנע היווצרות חלל ריק, אם יוחלט לספח שטחים נוספים וכשיוחלט. המדובר הוא במניעת היווצרות מצב הדומה, למצב שנוצר בירושלים עד לפרסום תקנות הסדרי משפט ומינהל תשכ"ט - 1968.
- ו. מינוי בית משפט מיוחד, יאפשר בדיקה של פסקי הדין של האיזור המבוקש ביצועם בישראל, ומאידך לא יהיה צורך שפסקי דין ישראליים יבדקו ע"י בתי משפט של האיזור, אשר להם חסרים גם הידיעה בשפה העברית וגם הידיעה בחוק הישראלי.
- ז. במידה ובמרוצת הזמן יתברר כי המצב הנוכחי ביחס להתדינות ישראליים באיזור, גורם לקשיים חמורים, ניתן יהיה להעניק לבית משפט מיוחד טמכות גם לדון בתביעות מעורבות. ברור לי כי החלטה כזאת כרוכה גם בשיקולים מדיניים, אולם מבחינה משפטית ומעשית הדבר יכול לפתור חלק מבעיות הנזכרות במבוא לפתרון בדרך אחרת.
